MINUTES

- 1. Chairman's welcome The chairman welcomed all to the meeting.
- 2. Present Councillor C Wild-Chairman, Councillor S Mason, Councillor S Hess, Councillor C Bonsey, Councillor H Carpenter & Apologies were received from Councillor S Durkam, Councillor N Biggs, Councillor R Purslow. Councillor G Jones resigned from the Council after the last meeting which he had been unable to attend due to health issues. The Chairman thanked him in his absence for his time on the Parish Council. Also present was L Pardoe, clerk to the meeting and 7 members of the public.
- 3. Co-option of New Councillor. Mr H Eccles expressed an desire to join the Parish Council following Ex Councillor Jones resignation. Councillor C Wild proposed that he be co-opted on to the Council this was seconded by Councillor H Carpenter and agreed by all members present.

Councillor Eccles took his seat at the table with the other members of the Parish Council.

- **4. Signing of Declaration of Acceptance of Office**. This was signed in front of members of the Council and witnessed by the clerk.
- **5. Declaration of Pecuniary Interests.** None were declared at this point.
- **6.** Council to agree the minutes of the March 2024 meeting. It was agreed these were a true and accurate record of the meeting. Proposed by Councillor C Wild, seconded by Councillor H Carpenter and agreed by all members present.
- 7. Public session.

- One member of the public reported that some people had been cutting through the Allotments where the new wall ended, and the new hedging plants were planted. They had further blocked this off and so far, this seemed to be working.
- Another MOP reported about the scrapping of the School Library Service which has not been brough to the public's attention.
- One member of the public reported that the potholes are terrible. A brief discussion was had about how Fix my Street was extremely busy with reported potholes.
- Andy Abbots who is heavily involved in local footpaths reported that there would be more work this year. They were asking for more volunteers to assist in clearing up the footpaths. This would probably start again in June when it is hoped that the weather would be better. They would be replacing gates with stiles.
